#### General Order No. 2022-04

The United States District Court for the Eastern District of Virginia has continued to closely monitor the outbreak of Coronavirus Disease 2019 (COVID-19), as well as the developing guidance from the Centers for Disease Control and Prevention (CDC) and state health authorities. Throughout the pandemic, the Court has relied on the guidance of health officials when determining which layered COVID-19 mitigation strategies best allow the Court to satisfy its constitutional responsibility to continue operations while at the same time protecting employees, judges, litigants, attorneys, jurors, stakeholders from other agencies, contractors, vendors, and members of the public that enter our Courthouses and Court facilities, to include those individuals ordered to appear.

In response to emerging CDC guidance and evolving community conditions, the Court has continued to review and modify employee and facility policies designed to reduce the risk of COVID-19 transmission. Most recently, the Court modified its internal employee quarantine policy governing COVID-19 exposures in order

to conform with updated CDC guidance. In conjunction with such internal policy update, the Court ended its practice of requiring unvaccinated Court employees and Court contractors to undergo routine COVID-19 testing. See Gen. Order 2021-12 (requiring twice weekly tests); Gen. Order 2022-02 (requiring once weekly tests).

Consistent with the recent update to the employee quarantine policy, the instant General Order adopts modified entry rules for our Courthouses and Court facilities such that members of the public will no longer be required to quarantine following a COVID-19 exposure. Instead, those exposed to a COVID-positive individual must wear a well-fitting high-quality mask while inside our facilities for 10 days following the exposure. The attached public notices reflect such change, as well as other minor modifications.

The Court will continue to monitor community conditions as well as updated CDC guidance to determine whether any future policy modifications are warranted.

It is so ORDERED.
